Amounts of the grants ranged from \$75 to \$1,425. Students were required to complete an application. Emergency financial grant recipients were eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965. Eligible students received \$75 for every credit hour for which they were enrolled in the Spring 2021 semester. Additional funds were given to FreightCar employees whose plant closed during pandemic. No WIOA funds available for students.
